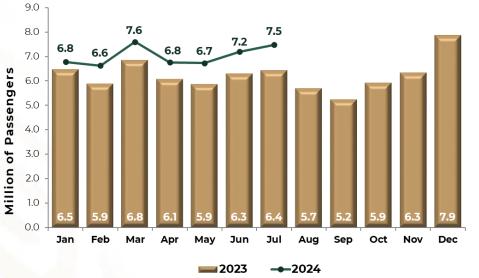




Arrival Of International Visitors to Mexico

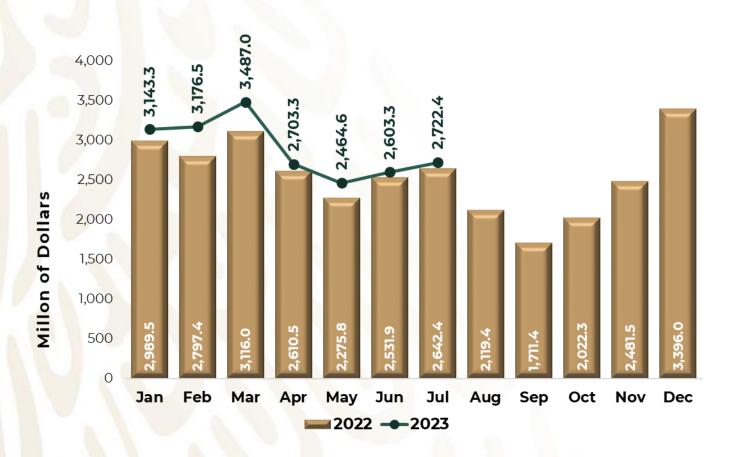

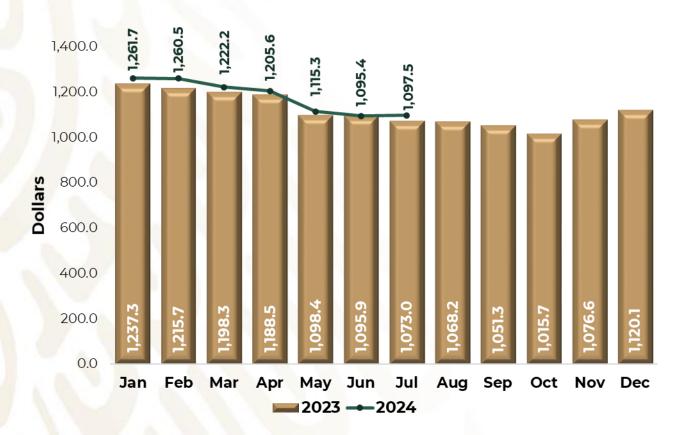

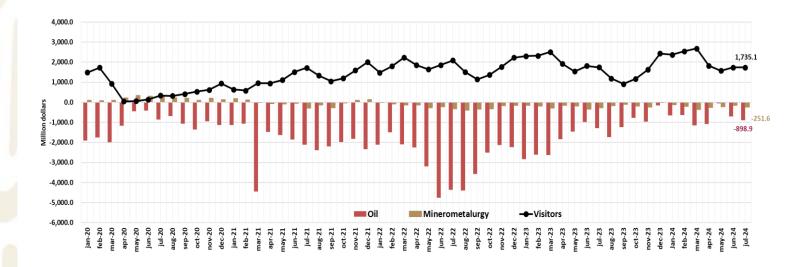

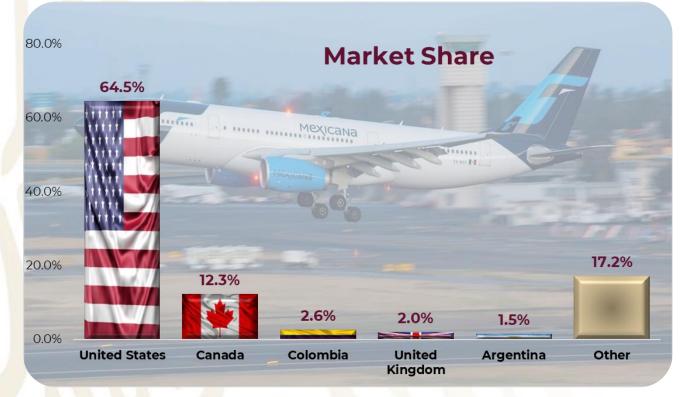

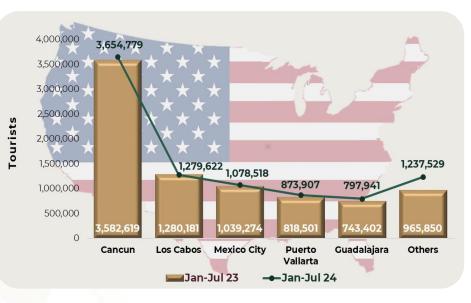




U.S Citizens by Airport

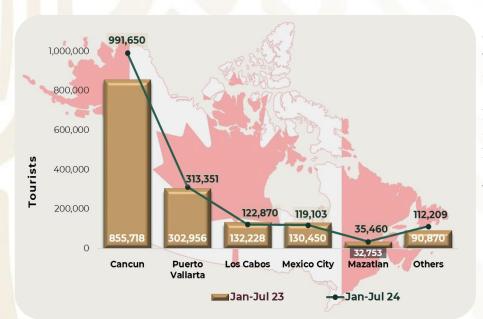

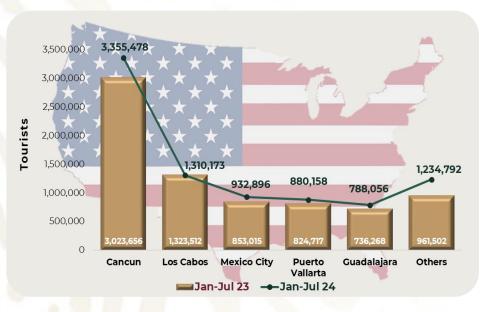


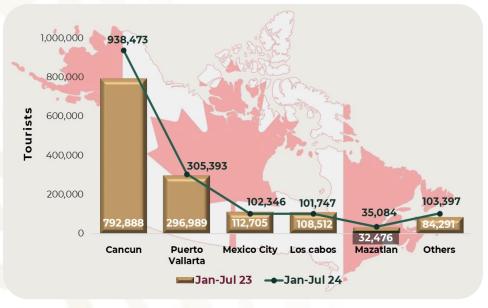

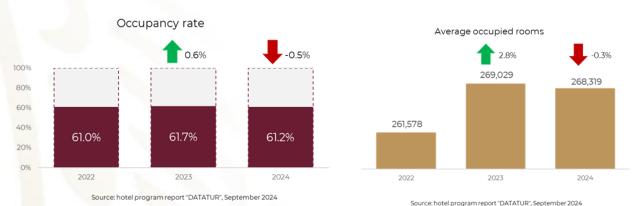






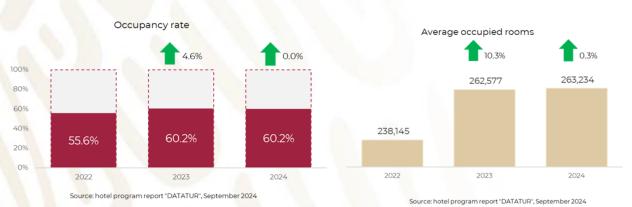

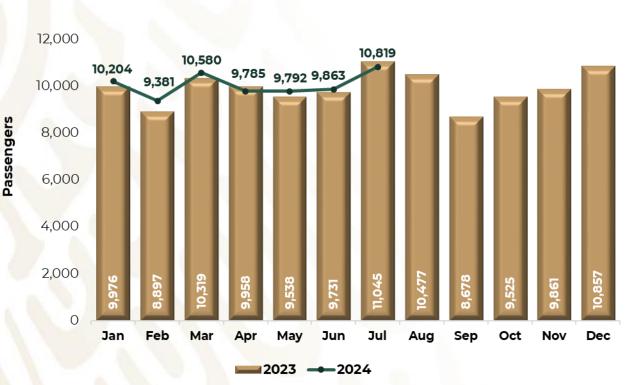

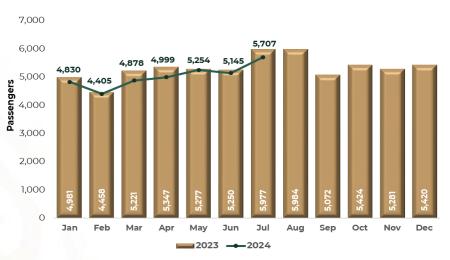

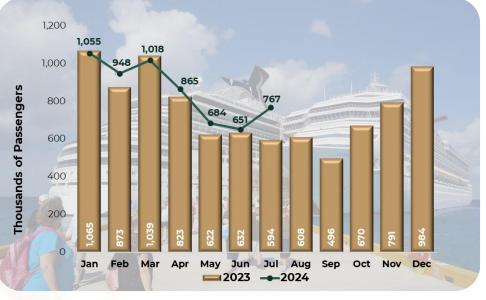

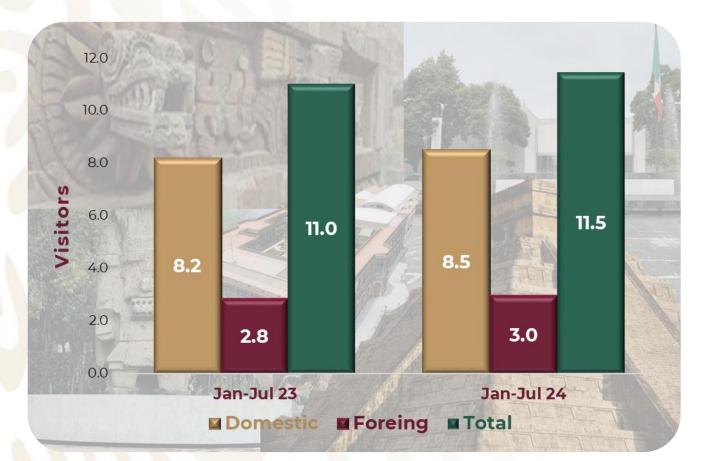




Visitors to Museums and Archeological Sites

National Tourist Price Index (NTPI) July 2024

The National Tourist Price Index is an economic indicator that monitors price fluctuations in representative tourist services in Mexico. Helps travelers, businesses and policymakers understand price trends in the tourism industry and impact on the national economy.



The NTPI consists of six key components selected for their economic importance and representativeness in tourism consumption, which recorded the following annual inflation:

International Traveller Account Index **June 2024**

The International Traveller Account Indices cover both the income and the flow of people entering the country, with the objective of measuring the monthly and annual variations accumulated to make a detailed monitoring of international tourism activity.

Foreign Direct Investment In Tourism

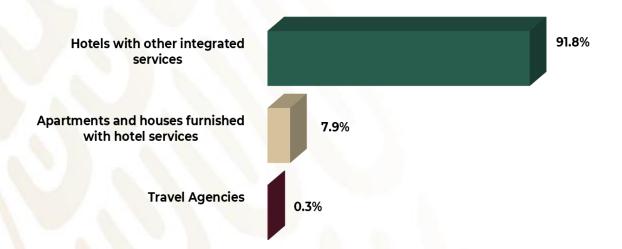
In the first half of 2024, foreign direct investment in tourism (FDIT) registered 1,373.9 million dollars, equivalent to 4.4% of National Foreign Investment and exceeding the 1,242.9 million dollars raised in 2019.

Foreign Direct Investment in tourism recorded in the second quarter of 2024, amounts to US\$ 820.2 million, equivalent to **16.1**% of domestic Foreign Direct Investment..

FDIT Participation by Type of Economic Activity

In the second quarter of 2024, Foreign Direct Tourism Investment stands out in:

- Hotels with other integrated services (752.7 million USD)
- Apartments and houses furnished with hotel services (65 million USD)
- Together these classes represent 99.7% of the total FDIT in that period

Tourist Employment Second Quarter of 2024

- The population employed in the tourism sector in Mexico amounted to 4 million 861 thousand direct jobs in the second quarter of 2024 and represented 9% of national employment; equivalent to an increase of +3.1% over the same period in 2023.
- With this result, an annual increase of 148,58 direct jobs was observed in the sector producing tourism goods and services.

Domestic

In the second quarter of 2024, the marked weakness that national economic activity has exhibited since the fourth quarter of 2023 prevailed. In particular, following the slight contraction observed in the last quarter of last year (quarterly change of -0.06%) and the marginal advance recorded in the first quarter of the current year (quarterly change of 0.11%), in the periodJune GDP grew at a quarterly rate of 0.16% (annual increase of 2.1% with seasonally unadjusted series and 1.0% with seasonally adjusted figures).

Economic Context (Bank of Mexico)

From a sectoral perspective, the economic performance during the second quarter of 2024 was mainly reflected by the sluggishness of secondary activities and the loss of dynamism in tertiary activities. Although secondary activities showed a 0.26% increase compared to the first quarter, this was insufficient to reverse the declines observed in the previous two quarters. In turn, the quarterly growth of 0.14% in services represented a clear lower dynamism than that exhibited in the first three quarters of 2023. Finally, primary activities decreased 0.24% compared to the previous quarter.

On the demand side, consumption has been weakening so far this year. In turn, between February and May the investment showed some improvement, after the stagnation recorded between September 2023 and January 2024. However, its growth rate has been significantly lower than that observed between the last quarter of 2022 and the third quarter of 2023. Finally, as for external demand, the value of exports in the period from April to July 2024 increased compared with the first quarter.

International

During the second quarter of 2024, global economic activity expanded at a slower pace than in the first quarter, although with mixed performance across countries. This was generally a reflection of weaker growth in emerging economies, following their robust performance during the first quarter. Advanced economies expanded at a faster rate than in the previous quarter. Purchasing managers' indices point to a rise in the services sector globally at the beginning of the third quarter. These indices also suggest a slowdown in manufacturing activity in emerging economies and continued sluggishness of this sector in advanced economies.

Recent world trade indicators showed growth relative to the first quarter. During the second quarter of 2024, the US economy grew faster than in the previous quarter, supported by strong domestic demand. Gross domestic product (GDP) grew at a seasonally adjusted quarterly rate of 0.7%, after increasing by 0.4% in the first quarter.

This performance mainly reflected positive contributions from private consumption, inventory change and non-residential investment.

In the euro area, economic activity expanded at a similar pace in the second quarter of the year to that observed in the first quarter. This was supported by the expansion in the services sector.
